Civil Division

Our State Counsel advise and represent the Government on a wide spectrum of legal matters, from constitutional law and regulatory issues to private law actions. They also play a key role in overseeing Singapore's legal profession, represent the Government in child and adult protection cases and act as the Protector of Charities.

International Affairs Division

Our officers in the International Affairs Division (IAD) advise the Government on international law matters, represent Singapore at international negotiations and disputes, and handle all formal requests for mutual legal assistance and extradition. IAD's role also includes the development of international law expertise for Singapore and coordinating treaty making activities for the Government.

Crime Division

Our Deputy Public Prosecutors uphold the rule of law by making charging decisions in criminal cases investigated by the Police and other law enforcement agencies. They also prosecute offences in the State Courts and the Supreme Court, and render legal advice to law enforcement agencies in respect of criminal matters.

Legislation Division

Our Legal Service Officers and Executives in the Legislation Division provide law drafting and legislative consultancy services to all ministries, organs of state and statutory bodies, publish the legislation online and maintain the online database to ensure that legislation is accessible to all.

Advocacy Group

Our Legal Service Officers focus on litigation and dispute resolution by representing the Government as State Counsel in domestic and international matters, and prosecute offences as Deputy Public Prosecutors, often in close collaboration with other legal divisions.

Legal Operations Group

Our Executives in the Legal Operations Group support AGC's legal divisions in registry operations and records management, litigation matters, multimedia services, mail and document services, data analytics and governance, and overall client satisfaction.

AGC-Legal Service Academy

Our Executives in the AGC-Legal Service Academy support the learning and development of AGC and Legal Service Officers across the public service through extensive training programmes, competency frameworks and knowledge resources.

Corporate Services Division

Our Executives in the Corporate Services Division perform central functions in areas such as Finance, Information Technology, Human Resources, Operations Management, Corporate Communications and Strategic Planning.
