Advocacy Group

Focusing on litigation and dispute resolution, our officers represent the Government as State Counsel and prosecute offences as Deputy Public Prosecutors, across diverse matters, often in close collaboration with other legal divisions.

Civil Division

Our State Counsel advise and represent the Government on a wide spectrum of legal matters. They also play a key role in overseeing Singapore's legal profession and act as the Protector of Charities.

Crime Division

Our Deputy Public Prosecutors uphold the criminal justice system and are responsible for prosecuting offences in Court. They also provide prosecutorial guidance and advice to prosecutors in other public service agencies.

International Affairs Division

Our State Counsel advise the Government on international law matters and represent Singapore at international disputes and negotiations. They also seek and render legal assistance to other countries on criminal matters.

Legislation Division

Our Legislation Division provides law drafting and legislative consultancy services to all ministries, Organs of State and statutory bodies, publishes the legislation online and maintains the online database to ensure that legislation is accessible to all.

Corporate Services Division

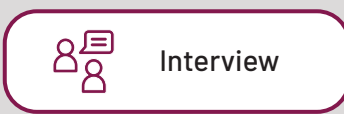
Our Corporate Services Executives perform central functions in areas such as Finance, IT, Human Resources, Facilities Management, Corporate Communications and Strategic Planning.

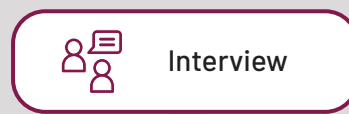

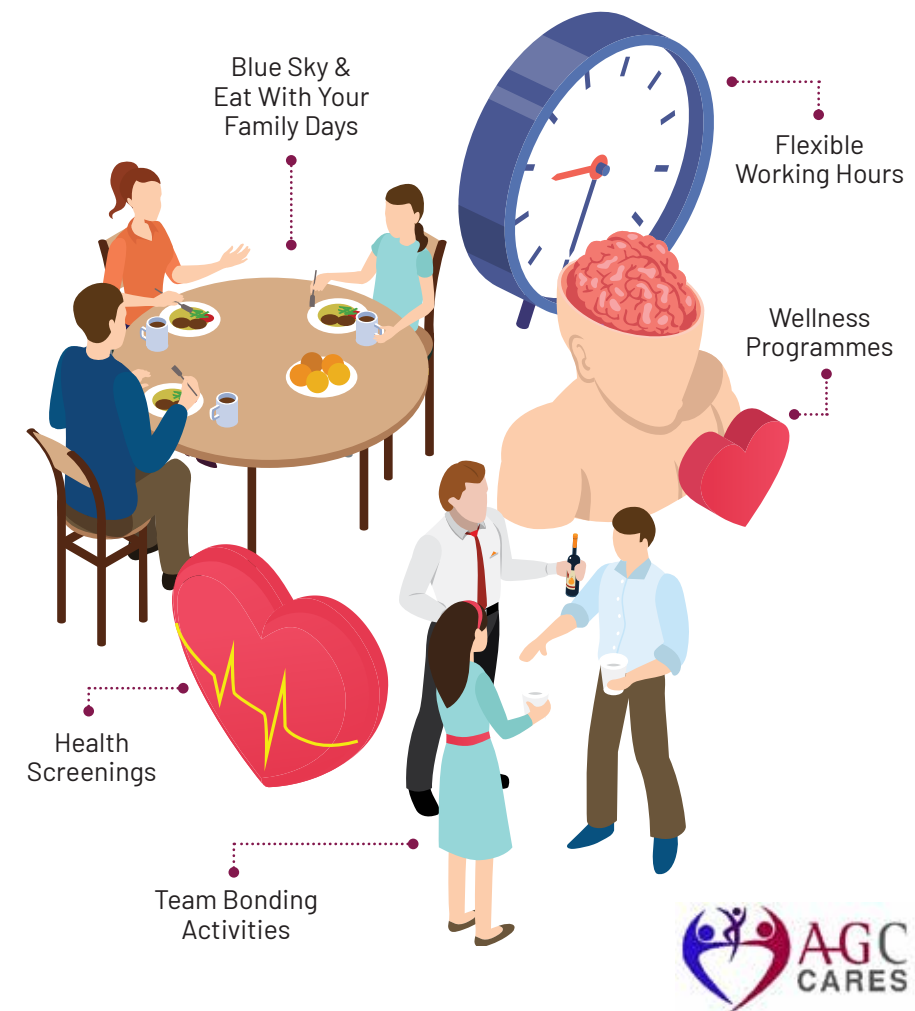
