SIGNING OF MEMORANDUM OF UNDERSTANDING ON COOPERATION BETWEEN THE ATTORNEY-GENERAL'S CHAMBERS OF THE REPUBLIC OF SINGAPORE AND THE SUPREME PEOPLE'S PROCURACY OF THE SOCIALIST REPUBLIC OF VIETNAM

The Attorney-General's Chambers of the Republic of Singapore and the Supreme People's Procuracy of the Socialist Republic of Vietnam have signed a Memorandum of Understanding ("MOU") to strengthen cooperation in the field of prosecution and in the fight against transnational organised crime.

- 2 The MOU was signed by Attorney-General Mr Lucien Wong and Prosecutor General Mr Le Minh Tri on 21 January 2019 in Hanoi, Vietnam.
- 3 Under the MOU, both parties will be able to embark on a wide range of collaborative activities. These include the exchange of information on the legal systems of both countries and best practices in law enforcement, as well as the joint training of prosecutors through various platforms.
- 4 The MOU marks a significant milestone in the relationship between both organisations, against the backdrop of the strong ties between the two countries.
- 5 Mr Wong is on an official visit to Vietnam from 21 to 22 January 2019 at the invitation of Mr Tri. During the visit, he will also call on Permanent Deputy Prime Minister Mr Truong Hoa Binh, and Minister of Justice Mr Le Thanh Long.
